Indigenous Education Report



Teacher Resource Review:

Secret Path is a collaboration between Gord Downie and Jeff Lemire, which chronicles the story of Chanie Wenjack, a 12-year-old boy who died after running away from Residential school in the 1960s. The story acknowledges a dark part of Canada's history – the long-suppressed mistreatment of Indigenous children and families by the residential school system – with the hope of starting our country on a road to reconciliation.

The story is in graphic novel-form, and can be used in the classroom with a variety of age groups. The MTS website also includes lesson plans categorized for Early, Middle and Senior Years.

The Public Services Sustainability Act

Bill 28 At A Glance

What is Bill 28?

Bill 28, *The Public Services Sustainability* Act, calls for public sector workers to have their wages frozen for two years, followed by a modest 0.75% increment in year-3 with up to a full 1.0% increase in the fourth year.

Assuming inflation continues to increase by a rate of 2%, the net effect of this loss to purchasing power will be compounded year-over-year to the tune of 6.2% at the end of the legislated wage pause. For an average teacher across this province, this translates to approximately a \$15,464 loss to every single teacher.

Why is Bill 28 Necessary?

In short, it isn't necessary. The Pallister government claims that the wage freeze is necessary to get Manitoba's fiscal house in order, stating repeatedly that it will take "all hands on deck" to tackle the deficit.

Since January 2017, Manitoba's public-sector unions have put forward practical solutions that would generate government revenue and negate the need for government to freeze wages and cut the services Manitobans count on.

However, the government opted to ignore these solutions and chose to introduce the heavy-handed legislation that undermines the collective bargaining process.

In response, Manitoba's public-sector unions have come together to create a Partnership to Defend Public Services (PDPS). The Manitoba Teachers' Society is proud to add its name to the list of 26 other unions who represent over 120,000 public-sector workers.

In June 2017, Bill 28 was passed, however the Pallister government chose not to proclaim the legislation. Regardless of when the act is proclaimed, the impact of the government's new law is already being felt at the bargaining table


So on July 4, 2017, the Partnership to Defend Public Services launched a legal challenge.

Why A Legal Challenge?

Bill 28 shows blatant disregard for the collective bargaining rights of the workers who provide public services to all Manitobans. As recently as November 2016, collective bargaining has been affirmed by the Supreme Court of Canada as a charter right. Not only is Bill 28 unfair, but it is unconstitutional.

This legal challenge will be long and the process will be slow. However, it is necessary for MTS to stand with other unions against Bill 28 so that we are united in pushing back against attacks on the rights of working people in Manitoba and the government's plans to cut the services our friends and families count on.

Garden Valley Teachers' Association Executive Meeting SUMMARY

Tuesday, November 7, 2017 @ 1:00pm Winkler Centennial Library – Meeting Room

- 1. **GVTA Executive Retreat**: On Tuesday, November 7th, the GVTA Executive held our annual retreat.
 - a. Our morning began with a presentation from Karen Wurr, Case Manager for Garden Valley with the Manitoba Teachers' Society Disability Benefits Plan. She spoke to the process that DBP uses for intake and case management. Ideally, they would have the opportunity to work with teachers before teachers reach the point where they feel they can no longer go in to work. Early intervention is key to success. Teachers who feel that they could use some assistance managing physical or emotional stress should call the plan office at 1-866-504-9373 (toll free).
 - b. We then worked with Terry Price, MTS Staff Officer in Professional and French Language Services. We worked on GVTA strengths, weaknesses, opportunities, and threats. The work we did here will guide us moving forward.
- 2. TRAF Webinar on Voluntary Contributions: The Teachers' Retirement Allowances Fund has a program where teachers can make voluntary contributions as payroll deductions. They presented a webinar on October 25 to this effect. The recorded webinar is now available for all members in the "AudioVisual Archive" of the secure portion of the TRAF website (at www.traf.mb.ca). - 3. **Equity & Social Justice and Indigenous Education:** GVTA has separated Equity & Social Justice and Indigenous Education into two separate portfolios, to help with the release time needed to attend professional development in these areas.
- 4. **ESJ Book Club:** Beginning in February or sooner, we are looking for someone to lead the ESJ Book Club which is about 15 members who meet on the first Wednesday of the month at CK's for food, drink, and discussion of a new book every two months. Contact your school rep or Joel.
- 5. **Maternity Leave Top-Up Grievance Settlement:** These grievances have been resolved. As of July 1st, 2017 all mothers will receive the same top-up for the first 17 weeks of their maternity leave regardless of what time of year they give birth. Many thanks are extended to the three teachers who filed grievances so that future mothers can receive this benefit, and thanks to the Board for offering a solution which will see all mothers treated equally.
